

2022 TACO BELL SURVEY SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **SPONSOR:** This 2022 Taco Bell Survey Sweepstakes (“Sweepstakes”) is sponsored by Taco Bell Corp., 1 Glen Bell Way, Irvine, CA 92618 (“Sponsor”).
2. **WHO IS ELIGIBLE:** This Sweepstakes is open to individual legal residents of the 50 United States and the District of Columbia who are age 18 or older at time of entry. Employees and their immediate family members and those living in the same household of Sponsor, independent administrator (“Administrator”), Yum! Brands, Inc., Taco Bell participating restaurants, and each of their respective affiliates, subsidiaries, advertising, promotion and internet agencies (collectively “Released Parties”) are not eligible. Void where prohibited or restricted by law.
3. **ENTRY PERIODS:** The Sweepstakes begins at 12:00 AM Central Time (“CT”) on December 29, 2021 and ends at 11:59:59 PM CT on December 27, 2022 (“Sweepstakes Period”). The Sweepstakes Period consists of the following thirteen (13) entry periods (each an “Entry Period”):

Non-winning entries **will not** carry forward into subsequent Entry Periods. Sponsor’s computer is the official time-keeping device for the Sweepstakes.

4. **HOW TO ENTER:** Enter the Sweepstakes:
 - A. **ONLINE:** When you purchase any food or beverage item at a participating Taco Bell restaurant in the 50 United States and the District of Columbia during the Sweepstakes Period, enter the unique code (“Code”) on your cash register receipt

at www.tellthebell.com and follow the on-screen instructions to complete a survey. After you complete the survey, you will receive one (1) entry into the applicable Entry Period.

B. BY MAIL: To enter without purchase, neatly hand print your first and last name, street address (no P.O. Boxes), city, state, zip code, phone number, email address, and date of birth (mm/dd/yyyy) on a plain piece of 3"x5" paper. Mail your entry in a business-size envelope (#10) with sufficient postage affixed to: 2022 Taco Bell Survey Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. Sponsor is not responsible for lost, late, illegible, incomplete, mutilated, misdirected or postage-due entries. Mailed entries must be post-marked by and received by the date indicated in the chart above in Section 3 to be eligible for that Entry Period.

Entry Limit: Regardless of the method of entry, limit one (1) entry per person per Entry Period. If more than one (1) entry is received from the same person/email address in the same Entry Period, the additional entries will be invalid.

5. **RANDOM DRAWINGS:** On or about each Drawing Date listed in Section 1, the Administrator will randomly select four (4) potential prize winners from all eligible entries received in the applicable Entry Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
6. **WINNER NOTIFICATION:** Winners will be notified within approximately one (1) week of each Drawing Date. Administrator will contact winners by telephone to request a mailing address for prize fulfillment. Administrator will leave one (1) voice message with instructions. If voice messaging is not available or if potential winner does not respond within three (3) business days, he/she forfeits the prize. A winner may be disqualified if his or her prize, winner notification or other communication is returned as undeliverable or if winner fails to respond within the timeframe specified in the winner notification. Prizes will be emailed to winners at the email addresses provided during winner verification/mail-in entry approximately six (6) to eight (8) weeks after verification.
7. **PRIZES:** Fifty-two (52) Prizes (4 Prizes per Entry Period): each, \$500 awarded via Chase Quick Pay. **PRIZE LIMIT:** one (1) prize per household. ANY USE OF A MINOR'S NAME, ADDRESS, LIKENESS AND/OR PRIZE INFORMATION IS SUBJECT TO PRIOR APPROVAL OF HIS OR HER PARENT OR LEGAL GUARDIAN.**

B. BY PARTICIPATING IN THIS SWEEPSTAKES: EACH ENTRANT REPRESENTS TO SPONSOR THAT HE OR SHE HAS THE LEGAL CAPACITY TO AGREE TO THE TERMS OF THESE OFFICIAL RULES AND HAS COMPLIED WITH THEM. THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
